MINUTES OF THE REGULAR WARREN CITY COUNCIL MEETING April 14,2025 5:30 p.m.

OPENING PRAYER: Opening prayer was led by Reverand Derrick Perry, Mount Carmel Baptist Church, Warren, AR.

PLEDGE OF ALLEGIANCE: Mayor Reep led the Council and audience in the Pledge of Allegiance.

<u>CALL TO ORDER:</u> Mayor Gregg Reep called the meeting to order. The meeting was held in the Council Chambers of the Municipal Building.

ROLL CALL: On roll call by City Clerk Janice Nelson, the following Council Members were present: Ward 1- Council Member Chanel Hooper and Joel Tolefree, Ward 2-Council Members Emily Moseley and Memory Burks-Frazer, Ward 3- Council Members Dorothy Henderson and Latanza Atkins. Absent – None.

Minutes of March 10, 2025, regular City Council Meeting: On a motion made by Council Member Henderson and a second by Council Member Tolefree, the Council voted 6-0 to approve the minutes of March 10, 2025. Yes votes — Council Members Henderson, Burks-Frazer, Moseley, Tolefree, Atkins, and Hooper. Nay-None. Absent-none. Motion carried.

City Clerk's Report

<u>Financial Statement:</u> City Clerk Janice Nelson provided the Financial Report to the City Council Members in their packets for review. On a motion made by Council Member Henderson and a second by Council Member Moseley, the Council voted 6-0 to approve the financial statement as presented by the City Clerk. Yes votes — Council Members Henderson, Burks-Frazer, Atkins, Moseley, Hooper and Tolefree. Nay — none. Absent — none. Motion carried.

<u>City Sales and Use Tax:</u> The report on the City Sales and Use Tax received since the tax was passed was presented to the Council for their information. The city received \$80,194.85 for the month of March 2025.

<u>County Sales and Use Tax:</u> A report on the city's portion of the County Sales and Use Tax received since the tax was passed was presented to the Council for their information. The city's portion received from the County for March was \$56,221.85.

<u>District Court Clerk's Report: The</u> District Court Clerk's written report for the month of March 2025 was presented to the Council.

Mayor's Report:

- 1. **Employee Recognition:** Mr. John McCoy with th<u>e</u> Warren Sanitation Dept. was recognized as Employee of the Quarter for the first quarter of 2025. Mr. McCoy came forward with his grandson Kasen McCoy and was presented with a \$100.00 gift card. Mr. McCoy took over the boom truck operation and has been with the city for about 2 yrs.
- 2. Update on Industrial Prospects: Ski Blu Carbon is progressing with production lines.
- 3. **Pink Tomato Festival Street Closing:** (see attached listing of streets.) Council Member Tolefree made a motion to approve the requested street closings for the Tomato Festival, Council Member Henderson seconded. The Council voted 6-0 to approve the requested street closings. Yes votes Council Members Tolefree, Henderson, Atkins, Burks-Frazer, Moseley and Hooper. Nay none. Absent none. Motion carried.
- 4. **Re-Appointment of Dale Wheeler to Planning Commission:** Council Member Henderson motioned to approve the re-appointment of Dale Wheeler to the Warren Planning Commission for a 3-year term, Council Member Burks-Frazer seconded. The Council voted 6-0 to approve the re-appointment of Dale Wheeler to the Warren Planning Commission. Yes votes Council Members Henderson, Burks-Frazer, Atkins, Moseley, Hooper and Tolefree. Nay none. Absent none. Motion carried.
- 5. Re-Appointment of Keneetratra Owens to the Warren Planning Commission:
 Council Member Henderson motioned to approve the re-appointment of Keneetra
 Owens to the Warren Planning Commission for a 3-year term, Council Member
 Burks-Frazer seconded. The Council voted 6-0 to approve the re-appointment of
 Keneetra Owens to the Warren Planning Commission. Yes votes- Council Members
 Henderson, Burks-Frazer, Atkins, Moseley, Hooper and Tolefree. Nay none. Absent

- none. Motion carried. Both Dale Wheeler and Keneetra Owens were nominated by Mayor Reep.
- 6. **Municipal Building Roof:** Mr. Rob Johnson explained that the city was using sprayon roof product and the city is just waiting for the temperature to be above 60 degrees for an extended period then the company will be able to apply the product.
- 7. **Lien Martin's Lot:** The property is private however the city does have a lien on the property. The owner does not want to pay the lien and is delinquent on taxes therefore eventually the state will take it over and put it up for auction.
- **B.** <u>Council Members Recognized</u>: Mr. John Harris came forward with concerns about the water pressure on W. Church St. where he currently lives. Mr. Harris stated that this was not just affecting his home but several others on the street. Mayor Reep stated that he would talk to the water department Director Tenay Reep to address this problem on his behalf and urged Mr. Harris to talk with the Water and Sewer Commission himself as well.
- **C.** <u>Signed in or called</u>: Mrs. A'Seneque Daniels came forward addressing the speed bump that is located on Lincoln St. Mrs. Daniels stated that the speed bump has flattened out over time and needs to be replaced. Mrs. Daniels also addressed the issue of the intersection of Bragg & Kelly St. being washed away on the sides and need to be repaired. Mr. Harris came back up to address needing a speed bump placed on W. Church Street as well. Mayor Reep stated the issue would be looked into and the mayor would get back to Mr. Harris.

Chief Hildreth stated that his department was still actively looking to hire additional police officers and had one officer graduating from the academy this week, giving the city another certified officer.

- C. <u>Fire Chief</u> Chuck Moore: Chief Moore gave his monthly March 2025 report to the Council. Chief Moore requested approval to send four firemen to the Annual Firmen's Convention June 4th-7th, 2025. Council Member Tolefree motioned to approve the request; Council Member Henderson seconded. The Council voted 6-0 to approve sending four firemen to the annual Firmen's convention in June. Yes votes Council Members Tolefree,

Henderson, Atkins, Burks-Frazer, Moseley and Hooper. Nay – none. Absent – none. Motion carried.

- **D.** <u>Fire Committee</u> Council Member Tolefree, Chairman. No meeting.
- **E.** <u>Sanitation Manager</u>: Rob Johnson gave his monthly report for the sanitation department for the month of March 2025. Council Member Tolefree mentioned that when garbage pick-up goes to the one time a week schedule that pickup days should be other days than Monday's and Friday's due to most holiday's falling on either of those two days. Mayor Reep stated that this subject would be discussed by the Sanitation Committee.
- F. Sanitation Committee: Nothing currently.
- G. Building Official: Mr. Rob Johnson
 - 1. Monthly Report- The monthly report for March 2025 was presented to the Council.
 - **2. Property Clean-up Complaints:** There were several letters sent out, but they have been cleaned by owners and are up to code.
 - 3. Condemnation List: Four properties are up for consideration for condemnation:
 - 1. #2 Railroad -
 - 2. 1406 W. Pine St.
 - 3. #3 Railroad Ave.
 - 4. 1402 W. Pine St.

Council Member Burks-Frazer motioned to place the four properties listed on the condemnation list; Council Member Atkins seconded. The Council voted 6-0 to place all four properties on the condemnation list. Yes votes — Council Members Burks-Frazer, Atkins, Henderson, Moseley, Hooper and Tolefree. Nay — none. Absent — none. Morion carried. The four properties that have been condemned previously, Mr. Johnson reported that the Rock St., Penister St., Southern Court and Phillips St. properties are still in violation of city ordinances. Mayor Reep stated that he intended to give the Rock St. site a little more time as some debris had been removed with some private help. Council Member Hooper made a motion to give Phillips St. more time for clean up before proceedings; Council Member Henderson seconded. The Council voted 3-3 for additional time. Yes votes — Council Members Hooper, Henderson and Tolfree. Nay — Council Members Atkins, Burks-Frazer and Moseley. Absent — none. Motion fails. Mayor Reep stated that the city would talk to the property owner again prior to starting the proceedings.

Mr. Johnson stated that the 90-gallon trash containers that were expected within 90 days of ordering have been pushed back until middle September for delivery. The recent storms in the country have restricted production and delivery.

 - **1. Monthly Report-** Mr. Hearnsberger presented the monthly report for March 2025. The Street Department is down by two part-time employees but will be doing interviews next week.

Council Member Henderson seconded. The Council voted 6-0 to enter a memorandum with Maribeth Frazer for funding and overseeing the tree project for the City of Warren.
